**Housing Rehabilitation Assistance Program**

The Housing Division at the City of Downey offers a Grant Program to renovate your home of up to \$35,000. The grant covers: most household repairs as long as they are not luxury items (i.e. swimming pools, spas, etc.), exterior paint, assistance with resolving code enforcement cases, assistance with improvements to address health and safety concerns, and assistance with ADA accessibility (i.e. ramps, railing, etc.). Additionally, there is also up to \$2,500 available, to remove lead based paint found at your home.

**Frequently Asked Questions**

**What Types of Repairs Or Improvements Can I Make?**

Eligible improvements include items such as solar panels, HVAC, roofing, painting, water efficient fixtures, plumbing, flooring, electrical, insulation, windows, walkways, doors, weatherproofing, driveways, bathroom repairs, kitchen repairs, termiting, etc.

**How Does It Work?**

Fill-out and submit your application and wait for a phone call or letter; City staff will schedule an appointment to review your household's income documentation (i.e. tax returns, 3-months of pay stubs, 3 months of bank statements, social security award letter, pension, and any other income documentation you may have). Once it has been determined that you qualify, a property inspection will be scheduled to inspect your home and review the areas you want to improve. A scope of work will then be generated by City staff and you will be asked to obtain a minimum of 3 proposals from different licensed contractors. You will then be asked to select your contractor, enter into an agreement with the City and commence work. Rebates will be processed after project is completed.

**How Am I Eligible?**

1. You must be the homeowner of the City of Downey property, reside in the home, and it MUST BE your primary residence (Proof of Residence).
2. Your household's gross income cannot exceed the current HUD income limits listed below.

**How do I Apply?**

The first step is to fill-out the application form on the reverse side and mail, drop-off, or e-mail it to the City's Housing Division (located at City Hall, First Floor), which will place you on the waiting list.
