**AN INTERIM URGENCY
ORDINANCE OF THE CITY
COUNCIL OF THE CITY
OF DOWNEY EXTENDING
A MORATORIUM ON THE
APPROVAL, COMMENCEMENT,
ESTABLISHMENT,
RELOCATION, OR EXPANSION
OF SINGLE PRICE OVERSTOCK/
DISCOUNT STORES WITHIN
CITY LIMITS FOR AN
ADDITIONAL ONE (1) YEAR
PURSUANT TO GOVERNMENT
CODE SECTION 65858**

Notice is hereby given that on May 12, 2026, the City Council of the City of Downey will consider the adoption of an extension of an Urgency Ordinance for a period of one (1) year, continuing a moratorium on the approval, commencement, establishment, relocation, or expansion of a single price/overstock discount stores (SPODS) within the City of Downey.

The City Council of the City of Downey adopted an urgency ordinance No. 25-1528 on May 28, 2025, to establish a 45-day moratorium on the approval, commencement, establishment, relocation, or expansion of a single price/overstock discount stores (SPODS) within City limits. On July 8, 2025, the City Council adopted Ordinance No. 2025-1529, extending the moratorium, which is set to expire on May 27, 2026, unless extended by the City Council.
